Pres. Deschane declared a quorum present and welcomed new Trustee Amy Deschane.

- 3) **Adoption of Agenda:** Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, that the agenda be adopted as presented. Vote: Ayes: 5. Motion carried.
- 4) **Minutes Approval:** Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, that the minutes of regular meeting of March 15th, 2016 be approved as presented. Vote: Ayes: 5. Motion carried.
- 5) **Financial Report:** Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, that the financial reports for all funds for the months of February and March be approved as presented. Vote: Ayes: 5. Motion carried.

However, Atty Culp, who is representing Gateway has not yet signed the lawsuit dismissal forms. Atty Boren also reported he had reviewed the sign ordinance regarding content of signs and feels that political signs are in conflict with the recent

Supreme Court decision. The League of Municipalities will be providing a sample sign ordinance soon addressing the court decision, which will be addressed by the Development Committee.

- 14) **Class B Temporary Beer & Wine License - Red, White & Music Fest:** (Finance) Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, to grant a temporary Class "B" fermented malt beverage and wine license to the Crivitz Firefighters Association for the Red, White & Music Festival event at John Shaffer Pavilion on May 28, 2016, from 11:00 am to 11:00pm, provided wristbands are issued and grounds monitored to control underage drinking. Vote: Ayes: 5. Motion carried.
- 15) **Municipal Court Clerk Conference:** (Finance) Motion by Trustee Kaminski, seconded by Trustee Stew Swanson, to approve Barb Uhl's attendance at the 2016 Municipal Court Clerk conference in September at a cost not to exceed \$800.00. Discussion: Pres. Deschane noted that attendance at this conference is required by the State of Wisconsin. Vote: Ayes: 5. Motion carried.
- 16) **July 4th Fireworks:** (Parks & Rec) Motion by Trustee Stew Swanson, seconded by Trustee Kaminski, to accept the contract with Spielbauer for July 4th fireworks at a cost not to exceed \$3,200.00. Discussion: Per the committee decision, July 9th is the rain date for the fireworks. Vote: Ayes: 5. Motion carried.
- 17) **July 4th Portable Restrooms - Jim's Pumping:** (Parks & Rec) Motion by Trustee Stew Swanson, seconded by Trustee Kaminski, to accept the quote from Bryce Harding of Jim's Pumping for 12 portable restrooms for July 4th at a cost not to exceed \$500.00, with 8 to be placed at the park and 4 at the flea market. Vote: Ayes: 5. Motion carried.
- 18) **July 4th Jumpers:** (Parks & Rec) Motion by Trustee Stew Swanson, seconded by Trustee Kaminski, to accept the quote from Jumpin Good Time for 2 jumpers at the park for July 4th at a cost of \$570.00, with cost to be shared between the American Legion, CBA and VFW. Discussion: The clerk explained that the vendor is covered for the jumpers and has provided a certificate of insurance. Also, the Village falls under the recreational immunity statute for any injuries that may occur at the park. Vote: Ayes: 5. Motion carried.
- 19) **Littleland Park Groundcover:** (Parks & Rec) Motion by Trustee Stew Swanson, seconded by Trustee Kaminski, to accept the quote from DTAK for Littleland Park groundcover at a cost not to exceed \$3,430.00 delivered, and to transfer needed funds from the Littleland Park savings to cover the expense. Vote: Ayes: 5. Motion carried.
- 20) **Triangle Park Irrigation Maintenance:** (Parks & Rec) Motion by Trustee Stew Swanson, seconded by Trustee Kaminski, to accept the contract with M & M Irrigation for 2016 triangle park irrigation maintenance in the amount of \$225.00. Vote: Ayes: 5. Motion carried.

- 21) **Triangle Park Waterfall Maintenance:** (Parks & Rec) Motion by Trustee Stew Swanson, seconded by Trustee Kaminski, to accept the 3-year contract with Loyal Landscaping for spring and fall maintenance at a total cost not to exceed \$1,365.00. Vote: Ayes: 5. Motion carried.
- 22) **Noise Ordinance Extension - Red, White & Music Festival:** (Public Safety) Motion by Trustee Duane Swanson, seconded by Trustee Kaminski, to grant permission to the Crivitz Firefighters Association to exceed the noise ordinance limits until 12:00 midnight on May 28th, 2016 for the Red, White & Music Festival at the John Shaffer Pavilion. Vote: Ayes: 5. Motion carried.
- 23) **Fireworks Licenses:** (Public Safety) Motion by Trustee Duane Swanson, seconded by Trustee Franzen, to grant fireworks licenses effective 5/1/2016 through 4/30/2017 to T & B One Stop, Witt's Piggly Wiggly and Victory Fireworks. Vote: Ayes: 5. Motion carried.
- 24) **Drainage Ditch Project:** (Public Works) Motion by Trustee Franzen, seconded by Trustee Stew Swanson, to contract with Robert E. Lee for permit application, construction and bidding services for the drainage ditch project in an amount not to exceed \$ 14,075.00, which does not include the cost of DNR or Army Corps of Engineer permits. Discussion: The culvert at Old W is to be taken out of the contract and project pursuant to a previous Public Works Committee decision. Vote: Ayes: 5. Motion carried.
- 25) **Street Sweeping:** (Public Works) Motion by Trustee Franzen, seconded by Trustee Stew Swanson, to contract with Mid Wisconsin Super Vac at the rate of \$85.00 per hour for 2016 street sweeping services. Motion amended by unanimous consent to add ' at a cost not to exceed \$5,000.00'. Discussion: Trustee Franzen noted this was the low bid. All curbed streets and one additional street by the school are planned to be swept. Vote: Ayes: 5. Motion carried.
- 26) **Part-time Public Works Employee:** (Public Works) Motion by Trustee Franzen, seconded by Trustee Stew Swanson, to hire Brian Scheuer as a temporary part-time seasonal Public Works employee at the rate of \$9.00 per hour not to exceed 840 hours effective retroactive to 4/11/2016. Vote: Ayes: 5. Motion carried.
- 27) **Operators Licenses:** None.

**OLD BUSINESS:** Pres. Deschane reported that Trustee Kostuch and Greg Gocht had selected locations for the Crivitz banners, with 2 being placed on Dyer St. and one on every block from USH 141 to F.J. St.

**NEW BUSINESS:** Pres. Deschane thanked former Trustee Shirley Keller for her years of service to the Village.
